

## ORDINANCE NO. 978

### **AN ORDINANCE OF THE CITY OF NORTH BONNEVILLE, WASHINGTON, CREATING THE POSITION OF ADMINISTRATOR/CLERK/TREASURER, AMENDING NORTH BONNEVILLE MUNICIPAL CODE CHAPTER 2.08;**

WHEREAS, the City and its union, ATU Local 757, entered into a binding settlement of various issues, including a unit clarification, in which the creation of an Administrator/Clerk/Treasurer position was stipulated; and

WHEREAS, the City Council wishes to amend chapter 2.08 of the North Bonneville Municipal Code to provide for the position; and

WHEREAS, the City Council wishes to make certain administrative revisions to update chapter 2.08;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH BONNEVILLE, WASHINGTON, DO ORDAIN AS FOLLOWS:**

#### **Section 1. Chapter Title**

The title of chapter 2.08 is hereby changed from "Clerk/Treasurer" to "Appointive Offices."

#### **Section 2. Section 2.08.005 Appointive Offices**

Paragraph 2.08.005, "Offices," is hereby created as follows:

In accordance with RCW 35A.12.020, there shall be two appointive offices, the office of Administrator / Clerk / Treasurer and the office of Clerk / Treasurer. Either office may perform the combined duties of City Treasurer and City Clerk.

#### **Section 3. Section 2.08.010 Clerk/Treasurer Combined**

Section 2.08.010, "Clerk/Treasurer Combined," is hereby revised as follows:

Pursuant to Sections ~~35.27.180 and 35.27.190~~ 35A.12.020 of the Revised Code of Washington, as it now exists or is hereafter modified being Chapter 58 of the Laws of 1945, the office of ~~Town~~ City Treasurer is hereby consolidated with and combined with the office of ~~Town~~ City Clerk. The Clerk / Treasurer or the Administrator / Clerk / Treasurer may fulfill the duties of the combined offices of City Clerk and City Treasurer. ~~The office of Town Treasurer is hereby abolished and the Town Clerk shall henceforth exercise all the powers and perform all the duties required by statute or ordinance to be performed by the Town Treasurer, and shall likewise perform such duties and have such powers as are provided by statute or ordinance to be exercised or performed by the Town Clerk.~~

**Section 4. Section 2.08.020 Appointment**

Section 2.08.020, "Appointment," is hereby revised as follows:

The offices of Town Clerk, as so combined and consolidated, Clerk / Treasurer and Administrator / Clerk / Treasurer shall be appointed by and shall hold office at the pleasure of the Mayor, upon confirmation by City Council. It is not necessary for the mayor to fill both of these offices.

**Section 5. Section 2.08.025 Compensation**

Section 2.08.025, "Compensation," is hereby revised as follows:

The compensation of the City Clerk / Treasurer shall be \$50,004 per year, or as delineated through the annual budgetary process determined and provided by the city's official pay plan, in concert with any applicable labor contract.

The compensation of the Administrator / Clerk / Treasurer shall be determined and provided by the city's official pay plan, exclusive of any labor agreements, unless the city elects to enter into a formal contract of employment with the incumbent.

**Section 6. Severability**

If any section, sentence, clause or phrase of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

**Section 7. Effective Date and Publication.** A summary of this Ordinance consisting of its title shall be published in the official newspaper of the City. This Ordinance shall take effect five days after publication.
